TOPIC 3

FIRE SAFETY ENFORCEMENT STATISTICS (JAN – DEC 2007)

INSPECTIONS & FIRE HAZARD ABATEMENT NOTICE (FHAN)

- 1. SCDF conducts enforcement checks on a regular basis to ensure that fire hazards and violations are detected and rectified. A total of 11,401 enforcement checks were conducted in 2007, 278 or 2.5% more than the year before.
- 2. Under the Fire Safety Act, a Fire Hazard Abatement Notice (FHAN) serves as a warning. When the hazard is not abated, a Notice of Composition (NOC) between \$300 and \$500 would be issued with court action being taken for serious cases. A Fire Safety Offence (FSO) is normally issued when the contravention is of a serious nature and warrants a heavier penalty than when a FHAN is served.
- 3. Last year, SCDF served 1133 Fire Hazard Abatement Notices (FHAN), an increase of 382 (51%) in numbers from the 751 FHAN issued in 2006. See <u>Table 1</u>.

- 4. The top 3 most common fire hazards spotted for which FHANs were served were obstructed exit (237 FHANs), poor maintenance of hosereels and fire extinguishers (224 FHANs), and exit sign out of order (167 FHANs).
- 5. The bulk of FHANs served last year were issued to industrial premises which accounted for 59% (664 FHANs) of the total FHANs issued. About 25% (282 FHANs) were issued to commercial premises and 4% (49 FHANs) to public entertainment outlets. See **Table 2**.

NOTICE OF FIRE SAFETY OFFENCE (NFSO)

6. On the whole, the number of Notices of Fire Safety Offence (NFSO) issued last year increased by 22% (i.e. 73 NFSO more) compared to 2006. See <u>Table 3</u>. NFSO for change of use without approval rose by 93, while that for carrying out fire safety works dropped by 22. The enforcement checks conducted at an industrial premises located at Bukit Batok Crescent detected over 50 unauthorised change of use contributing towards a rise in the issuance of NFSO in 2007.

7. There was an increase of 29 FSOs' served to industrial premises last year. See **Table 4**. FSO for commercial premises however saw a decline of 10 cases.

NOTICE OF COMPOSITION (NOC)

8. <u>Table 5</u> shows a slight increase in number of Notice of Composition (NOC) served to violators. While there is a drop in the number of NOCs served to industrial premises, there is an increase of 20 NOCs served to commercial premises. In total, commercial premises were issued with 25 NOCs last year.
